Freestanding directional sign

1. The Trust objects to this application because of its size and prominence. It will have a negative impact on the conservation area.

Context

2. Pimlico and the triangular greenspace that this sign is placed on form a particularly distinctive entry point down to the Riverside, Prebends Bridge, and the World Heritage Site (WHS). This section of Pimlico and adjoining open space remain in contention as part of the WHS boundary expansion. The footpath access to Prebends Bridge is possibly of historic origin. South Street is thought to be an early route. The section of road and its paths together with the surrounding tree areas are of high character value within the conservation area and help to form the setting to the WHS. The area is included as part of the River Wear Corridor local open space designated in the Durham City Neighbourhood Plan (Policy G2, Area 1)

Proposals and Impact

The sign is large, prominent, and not of a style that is appropriate for the Conservation Area. The Trust notes that the sign was erected and then removed leaving the support posts in place and that need removing. Even though the application is only for one year (starting in April 2024) the Trust has concerns that there is cumulative clutter together with the necessary street signage on this street corner.

Conclusion

3. The Trust concludes that the impact of this proposal is negative, and that the application should be refused.
