Replace 1no. ground floor window to front

The Trust objects to the removal of the existing window and its replacement. It considers that there will be loss of an earlier window frame and negative change to the character of the building. There is a lack of clarity and supporting research for the window proposal in the submission in terms of heritage assessment and structural implications.

The context for this proposal is that the distorted front windows have been part of the building for a very substantial period ( at least 50 years). They are a very distinctive feature, essential to the character of the building and Saddler Street and familiar to Durham City residents. The building appears to have experienced movement, possibly causing the frame to buckle. If removed there may be consequences, and this needs further exploration. Removal and reuse of the existing glass may well prove very difficult. The corner has curved panes, again essential to the character of the frontage and its entrance. The street character plays an important part in forming an appropriate route into the World Heritage Site. It also has a role in attracting visitors and customers to the street and restaurant premises such as this. Ensuring that character is maintained should be considered a visitor and commercial factor.

The Trust is therefore concerned that there is insufficient research into the age and structure of the window. There may be indications of an earlier installation date. The proposal will remove existing framing and replace it with a regular frame, with no indication of how the curved glass is to be retained or replaced. The proposal is very basic and needs greater sensitivity to the significance of the building and windows in this important location. The Trust considers that the loss of the existing frame and the new replacement will create unacceptable character change and negatively impact the building and street. The damage to the window is very unfortunate but repair should be the solution. (The policies the proposal fails against are listed in the following appendix.)
